Invitation to an information meeting electricity substation Uilenburg

Dear resident or business owner,

We are pleased to invite you to an information meeting on the upgrade of the electricity substation at Nieuwe Uilenburgerstraat 27.

The meeting will be held on:

- Date: Tuesday 14 May 2024
- Time:
 - from 6.30 p.m. Arrival (coffee and tea provided)
 - 7 p.m. – 8.15 p.m. Plenary presentation (in Dutch)
 - 8:15 p.m. – 9.15 p.m. Information market where you can talk to experts from Liander and the Municipality of Amsterdam
- Location: Uilenburgersjoel, Nieuwe Uilenburgerstraat 91
- **There is no need to register**

NB: the plenary presentation will be filmed. We will ensure that visitors do not appear recognisably in the video. You will be able to watch the recording at a later date. We will notify you once it has been posted online.

Background

During the last open evening held on 30 October 2023 Liander and the Municipality of Amsterdam presented three options for the site of the electricity substation. Bureau Bewonerszaken then conducted another neighbourhood survey. The report of this survey was published in February 2024.

Over the past few months we have carried out further research into the different options. We have examined their technical feasibility and the reactions given in the neighbourhood survey. A new option has emerged as a result of this process. You can find out more about it in the information pack at liander.nl/Uilenburg.

Site decision by the Municipality

This summer the project team will ask the Executive Committee of the Centrum District to make a site decision relating to the upgrade of the electricity substation on Uilenburg, on the basis of the new option. To ensure the Executive Committee is well informed, we have had two additional studies carried out:

- A study by the engineering consultancy Royal HaskoningDHV, looking into alternative sites outside Uilenburg island.
- A calculation of the electromagnetic fields (EMFs) associated with the new option.

At the end of the plenary presentation there will be an opportunity to react to what you have heard and read. We will document these reactions in the report that we will enclose with the request for the site decision.
